Launched 2021	The helpline provides free and confidential information and advice to international protection applicants and refugees on the international protection process, Direct Provision and Family Reunification. It is an important part of our triage system where people can also be referred to our teams and other organisations for more support.
<u>Ukraine Helpline</u> 01 913 1528	Beneficiaries of Temporary Protection.	Launched 2022	The dedicated helpline provides confidential, and free information in Ukrainian and Russian on accessing temporary protection, education, accommodation, employment and healthcare. The service also refers internally and externally for more services.
